




Om åpningen til beskyttelseslokket dekkes til under bruk, for eksempel av smuss eller for at du sitter på lokket, stenges vannsirkulasjonen av. I de tilfeller bør du stenge av badekaret et minutt, og deretter rengjøre avløpet om det behøves. Deretter settes badekaret i drift på nytt.





- System baths are equipped with a specially protective drain cover (Safety Cover). If the openings in the drain cover close up during use, e.g., through dirt or because you are sitting on it, water circulation is deactivated. In this case you should switch off the bath for 1 minute and, if necessary, clean the drain. Then set the bath into operation again.

Warning:

- Safe use of the system is not assured if the safety cover is loose, missing, or defective.
- Should the safety cover be damaged or defective, have it replaced by a skilled person.







Oppvarming (tilvalg)


Varmeelementet installeres i massasjeesystemet i første omgang for å kompensere for temperaturtap som skjer i badekaret. Varmen kobles av og på automatisk når vannmassasjen er av. Temperaturen på badevannet reguleres konstant til 38 °C ved hjelp av en termostat. Anvend ikke salt eller klor. Unngå også at badevannet blir for mørkete da det kan oppstå problemer i varmesystemet.






Heating system (option)

Heating systems are primarily used in whirlpool systems in order to compensate for temperature loss in the bath. The idea is not to heat the bath water as such.

The heater will switch on automatically when the water massage is on and switch off automatically when the water massage is off. The heater is supplied with a thermostat that regulates the temperature of the bath water at approx. 38 °C. Do not use salt, do not use chlorine and do not use very dirty water in the bath, to avoid problems with the heating system.

GARANTEE

24 months warranty for the consumer is provided, if the installation and maintenance instructions have been followed. The warranty does not apply if the product is changed (eg through extra holes drilled) in any way not specified in the accompanying installation and user manuals. For professional use, the warranty period is 12 months.

10 years duration on the bath itself. This guarantee covers: manufacturing faults, colour changes and/or cracks. Formed as a result of the ageing of material and/or distortions caused by hot water.

5-year material warranty. The same conditions as above, but only for spare parts , not for labour for the replacement / repair.

If the buyer discovers defects in the delivered product, the notification shall be made right in due time. Villeroy & Boch Gustavsberg AB is held responsible within a reasonable time to change the defect product part or replace the product.

The warranty does not cover consequential damages to person or property caused due to errors in the delivered product. The manufacturer is not liable for the consequences of an incorrect installation.

Notification must be made to your dealer immediately after the fault has been detected. If such notification is not done, even though the buyer discovered or should have discovered the defect, the buyer loses the right to invoke this guarantee.
